



WARRANTY AGREEMENT

This Warranty Agreement is entered into by and between THE STACKER COMPANY LLC, located at 4111 NW 132 ST, OPA LOCA, FL 33054 (hereinafter referred to as the "Seller"), and _____ (hereinafter referred to as the "Buyer"), and is effective as of the date of delivery of the equipment.

1. WARRANTY COVERAGE

1.1 Standard Warranty

The Seller warrants that the equipment sold will be free from defects in material and workmanship for a period of **12 months or 2,000 working hours**, whichever occurs first, from the date of delivery, excluding components listed as exclusions.

1.2 Component-Specific Warranty

- **Mechanical Components** (e.g., frame, mast, forks, lever, gearbox, axle):
Covered for **12 months or 2,000 working hours**, whichever occurs first.
- **Hydraulic Components** (e.g., gear pump, steering gear, cylinder, valve):
Covered for **12 months or 2,000 working hours**, whichever occurs first.
- **Electrical Components** (e.g., controller, charger, motor, accelerator, instrument panel):
Covered for **12 months or 2,000 working hours**, whichever occurs first.
(Camera batteries excluded.)
- **Battery Modules Systems**, including BMS, DC converters, relays, fuses, and battery:
Covered under the same electrical component warranty (12 months / 2,000 hours).



2. WARRANTY CONDITIONS

- All warranty claims must be submitted in writing within the applicable warranty period.
- The Seller reserves the right to inspect the equipment to verify any claim.
- Warranty applies only to equipment used under normal operating conditions and with appropriate maintenance.
- All warranty repairs must be performed by an authorized technician or service center.

3. EXCLUSIONS

This warranty does **not** cover:

- Components subject to **normal wear and tear**, including but not limited to: filters, belts, tires, fuses, lamps, and paint.
- Damage caused by misuse, overloading, negligence, abuse, accidents, modifications, or unauthorized repairs.
- Failures resulting from lack of routine maintenance or operation outside recommended specifications.

4. LIMITATION OF LIABILITY

- Seller's liability under this warranty is limited exclusively to the repair or replacement of defective parts.
- In no event shall the Seller be liable for indirect, incidental, or consequential damages of any kind, including but not limited to loss of use, loss of profits, or downtime.



5. WARRANTY VOID

This warranty shall be void under any of the following conditions:

- Equipment not registered within 30 days of delivery (if required).
- Use of non-original parts or accessories not approved by the Seller.
- Transfer of ownership without written notice to the Seller.
